The Board of Mayor and Aldermen of the Town of Kimball, Tennessee, met at regular meeting on the 28th day of April, 1966, all members being present.

Minutes of last meeting were read and approved. Financial report was given.

The Board of Mayor and Aldermen of the Town of Kimball, Tennessee, met at regular meeting on the 12th day of May, 1966, all members being present.

Minutes of the last meeting were read and approved, and financial report was given.

The lease of the Kimball School property was read and discussed and executed by the Mayor and Aldermen on behalf of the Town. The Town Attorney was directed to have the lease properly recorded.

Mayor Bennett stated that he had requests for tile for private driveways and asked the responsibility of the Town to furnish such tiles. Upon advice of the Town Attorney, it was decided that the Town should not adopt the policy of furnishing tile for private driveways. Upon motion duly made, seconded and passed by unanimous vote, \$2,000.00 was appropriated from the fund for improving the Kimball School property.

It was agreed to make application to the City of South Pittsburg to install city water in the building.

Mayor Bennett was authorized by unanimous vote of all members present to secure fire insurance on the building and was further authorized to investigate the cost of installing restrooms in the building.

October 10, 1966

The Board of Mayor and Aldermen of the Town of Kimball, Tennessee, met at regular meeting on the 10th day of October, 1966, all members being present.

Minutes of the last meeting were approved and report as to finances was given, after which a general discussion as to the possibility of growth in the Town was held. It was generally agreed that the prospects of residential growth and industrial and commercial growth appeared better than at any time in recent years. The members of the Board were in agreement that the completion of the Interstate Highway and the fact that an interchange to the Interstate Highway would be located in Kimball would very likely result in much greater growth within Kimball than has occurred at any time in the past. It was agreed that in order to encourage development the Town would be required to furnish more services than in the past and that means should be devised to raise added revenues to meet such anticipated additional expenses as improvements will require. It was unanimously agreed to investigate the possible revenue that a property tax could be expected to produce. The Town Attorney stated that under the present law Kimball could levy a tax of \$0.75 per ~~\$100~~ \$100.00 of assessed valuation and that the county tax records could be used to get an estimate of the revenue such a tax would produce if based upon present county assessments. It was unanimously agreed to employ Mrs. Thelma Neal to spot the Kimball assessments on the County Tax records and to direct the Town Attorney to estimate the probable revenue that a Town property tax would produce, and, if possible to give an estimate of the revenue that could be expected from a levy of privilege taxes within the Town.

There being no further business the meeting was adjourned.

The Board of Mayor and Aldermen of the Town of Kimball met at regular meeting on the 8th. day of December, 1966, all members were present.


Minutes of the last meeting were read and approved and a financial report was given.
